*******PASTURE RENTAL AGREEMENT*******

1. Members, not using the pasture in the previous year will have first chance on pasture rental, up to May 1st.
2. Each member may have no more than two horses in the pasture at a time, unless no other member has requested a spot and the maximum number of horses allowed in the pasture has not yet been met.
3. The maximum number of horses allowed in the pasture is six, mares or gelding only. No mixed gender in the pasture. It will be determined by the 49er's Saddle Club Pasture Rental Chair person each year what gender will be in the pasture for the rental season.
4. No stallions or Mare's with foals are allowed in the pasture, horses must be yearlings or older.
5. If your horse is causing trouble in the pasture, you will be asked to remove it.
6. All members pay their first and last month's rental up front, before your horse may be placed in the pasture. For every month after that all payments are due by the 5th of each month, if the chair person doesn't receive the payment in a timely manner, or has not been notified that payment has been receive, then the renter will be notified that they will have 15 days from the time the rent was to be paid (the 5th of each month) to pay their pasture rental fees. If such fees have not been paid, the renter will have 10 days to remove their horse, or horses. In the event your horse(s) are not removed, the Nez Perce County Sheriff will be notified to take proper action for removal.
7. ALL horses placed in the pasture must be current on their vaccinations (including Rhino-Flu) and be wormed. You will be asked to provide proof before your horse may be allowed in the pasture.
8. Renter may not substitute a horse in the pasture without a new contract being signed.
9. Emergency contact information must be provided for all horses in the pasture, (including your vet information) the 49er's Saddle Club is not liable for your animal and must have contact information on file encase of an emergency.
10. The rental fee per horse in the pasture is \$60.00 dollars per month, for members only.
11. Horses will be put out on pasture no sooner than May 1st, (weather condition permitting) and will be taken out no later than October 31st of the same year. The pasture rental chair person must be notified with any changes.
12. Full season renters (paid members) will have priority.
